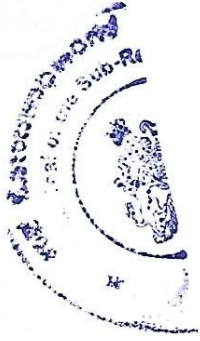

NOW THIS DEED WITNESSETH

1. DECLARATION

That I undersigned do hereby declare that I have irrevocably settled an amount of Rs.1000/- (Rupees One thousand only) for the sole purpose that it should form the nucleus and corpus fund of **Kediyoor Educational Trust** and that it has been accepted by the Trustees who have consented to act as Trustees subject to conditions hereinafter stated.

2. NAME

Name of the Trust shall be **KEDIYOOR EDUCATIONAL TRUST**.

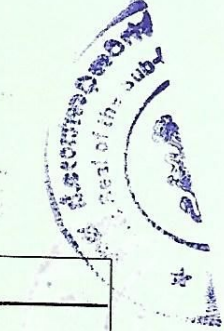



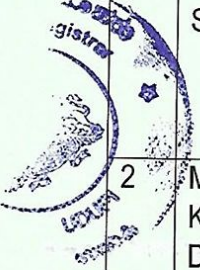

All the first six trustees named above will hold office as trustee for their life. As regards life trustees, their position will be that of a hereditary trustee with right to nominate their successor by notice of nomination to the trust to take affect either forthwith or after their lifetime or by nomination of their successor in their will. In absence of nomination either by notice to the trust or in their will, their eldest son of life trustee and in case he is not willing, the next male member in seniority in age among their legal heirs would be the hereditary trustee in their place. There will be a similar right of nomination or succession to the post by their successor so that the position of their office will be hereditary. The trustees can nominate only the family members as their successors.

The Trustees will have the right to co-opt any other family person only as a trustee for life or for a fixed term by consensus of all or by three fourth majority of total strength of the Board of Trustees. However, the total number of Trustees shall at no time exceed ten.

(ii) **Chairman and Managing Trustee:-**


The Author will be the first Chairman and the first Managing Trustee. Either post can be held by any other person chosen by consensus among the trustees and in absence of such consensus any trustee chosen by majority of the trustees.

(iii) **Board of Trustees:-**

All the Trustees will be collectively known as Board of Trustees. The properties of the trust shall be vested and managed by the Board of Trustees. The Board of Trustees shall consist of not more than Ten members.

(iv) **Succession:-**

In the event of any vacancy in the Office of the Managing Trustee by resignation or otherwise, any one of the Trustees as set out in (i) above will be chosen by the Board of Trustees as Managing Trustee in the manner provided in (ii) above.

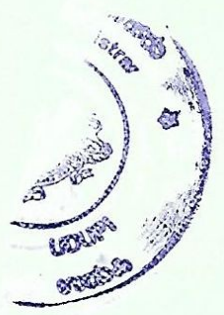

5. OBJECTS

The objects of the Trust are :-

a. Educational

- i. To support and promote the advancement of educational activities at all its branches such as kindergarten, Primary and High School, Colleges, leading to teaching Degree, Post Graduate and Doctorate courses in Arts, Science, Commerce, Engineering, Medicine, Pharmacy, Dental, Nursing, Para medical, Management, Music and Fine Arts, Architecture and such other subjects as the Trustees may deem fit for the benefit of students.
- ii. To promote the art and culture of the people irrespective of their caste, creed or religion.
- iii. To establish newly or by taking over, provide, endow, equip, furnish, maintain, develop, control and improve extend, grant donations in cash and kind and assist in the establishment, maintenance, running, development, improvement and extension and manage and conduct all educational institutions of the kind described in clause (i) above.
- iv. To engage teachers, instructors, administrative staff and experts of good moral character and conduct who are able to impart efficiently and economically up-to-date instructions to pupils and students in modern sciences, industrial vocations, research, intellectual and other useful pursuits.
- v. To bring out, encourage and develop the inventive and research faculties of the pupils and teachers and to afford opportunity for research in all branches of science and humanity.
- vi. To negotiate and enter into agreement with any Government, University, University Grants Commission, any Municipality or any other public or private authority, which may deem conducive or beneficial to any of the objects of the Trust, or be intended to enhance, improve or render more efficient the property, work of activity of the Trust.

- vii. To establish, maintain or acquire library or libraries for the benefit of the students community.
- viii. To establish, maintain and run a boarding house and residential accommodation for students and those connected with the institution.
- ix. To charge moderate tuition fees and otherwise recoup themselves for the outlay and expenses incurred in the upkeep and maintenance of institutions established or about to be established under this deed.
- x. To institute and award scholarships and loans for educational pursuits to deserving students.

b. Medical :

- i. to run, maintain or assist any medical institution, nursing home or clinics or to grant assistance to needy and indigent persons for meeting the cost of medical treatment.
- ii. to establish newly or by taking over, provide, endow, equip, furnish, maintain, develop. Control, manage and conduct hospitals in all or any of their departments and functions, providing medical, surgical and nursing care or treatment for indoor and outdoor patients, asylum, old-age homes, orphanages and such other institutions and facilities as the Board of Trustees may deem necessary or convenient for any of its purposes, all of which are charitable and not an activity of profit.

c. Yoga

Establishing and managing organizations and courses for the development of Yoga education with the objective of enabling the citizens to have good health, mental hygiene, emotional stability, moral values and higher level of consciousness and providing all types of financial assistance in achieving the said objectives.

- d. **Preservation of environment (including watersheds, forests and wildlife) and preservation of monuments or places or objects of artistic or historical interest. ...7**

e. **Relief of the poor:**

To give financial or other assistance in kind by way of distribution of books, notebooks, cloths, uniforms, or meals for the poor and indigent.

f. **Other objects of general public utility :**

- (i) to acquire property for the sole use for public good by making it available for public purposes as for example, housing a library, clinic, crèche and/or as a community hall to be available for public use as training classes, seminars, discourses and other public functions for benefit of the community in general.
- (ii) To purchase, construct, take as lease land buildings and other immovable and movable property as the trustees may deem necessary for carrying out the objects of the trust.
- (iii) To accept donations, grants, presents and other offerings and deal with the same for the purpose of the Trust.
- (iv) To undertake any other activity incidental or conducive to the above activities but which are not inconsistent with the above objects.

If any of the above objects is found to be inconsistent with the objects of a public charitable institution under section 11 or any other section of the Income-tax Act, 1961 or any other direct tax law or any other law applicable to such trusts as now enacted or as may be enacted or amended at a future date, the objects stated above will be treated as so modified to accord with such law or amended law so that any concessions, privileges, conditions or regulations available to and applicable to such public charitable institutions will be available or applicable to this Trust as well so that this Trust will continue to retain its character as a public charitable institution without profit motive with public character within the meaning of all such laws. All the objects of the trust and its activities will be confined to India and will be carried on without profit motive and without any distinction on account of caste, creed, colour or religion. ...8

6. The benefits of the trust shall be open to all irrespective of caste, creed or religion.

7. **CONSTITUTION OF BOARD OF TRUSTEES**

The Board of Trustees shall have as its members all Trustees whether appointed by this indenture, with the Chairman and Managing Trustee being the Trustees mentioned in the Article 4 above. Chairman of the Board will preside over the meetings and conduct the proceedings. In his absence, any other Trustee chosen by the members attending the meeting will preside over that meeting.

Any trustee can be removed from Trusteeship for insolvency or misconduct after a resolution by consensus of all other trustees after opportunity to him in writing. In case of necessity for such removal of hereditary trustee, the next in succession as per clause 4 will be the next hereditary trustee.

The Trustee may, if he so desires, resign his trusteeship and he shall cease to be a Trustee upon the acceptance of his/her resignation by the Board.

All references to trustee or trustees in this indenture is to those trustee/s authorized by Board of Trustees.

8. **POWERS OF BOARD OF TURSTEES**

- (i) Board of Trustees shall have the power to receive donations so as to augment the Trust Funds or to treat such donations for the purpose of the Trust either towards corpus or other funds eligible to be spent or applied according to the objects of the Trust.
- (ii) Boards of Trustees shall have the power to invest the funds in best possible manner with a view to augment the resources of the Trust to be able to better fulfill the objects of the Trust, but the Trust will not embark on any business or invest in any speculative venture. Such investments will also not deviate from the

- (ix) Board or Trustees may invite any employee, expert or well-wisher to attend Trust Board meeting for advice and participation without right to vote.
- (x) All properties, whether movable or immovable, whether owned or entrusted to the Trust by any person or body for management will stand vested in the Trust and will be subject to control and supervision of the Board.

9. FUNCTIONS

Without affecting the generality of powers and functions of the trustee/s to manage and administer the trust, the trustee/s shall have the following functions:

- (i) To borrow, if need be, against the security of the assets of the trust by way of bank overdraft, loan or otherwise, as may be necessary, for the benefit of the trust and for more effectively carrying out the objects and to bind the trust property for the purposes and enter into any agreement and sign such document authorizing the Managing Trustee and the Secretary jointly to execute such documents, deeds, papers, etc as may be necessary in connection therewith.
- (ii) To arrange for and/or authorize the signing of or execution of any agreement, contract, instrument, document or any other paper or writing required to be signed or executed on behalf of the trustees by the Managing Trustee and the Secretary jointly and to make the same effective and binding as if the said agreement, contract, instrument or document or paper or writing were signed by all the trustees.
- (iii) To appoint or make provision for the appointment of one of the trustees or any other person as Honorary Secretary or have a sub-committee of trustee/s or have a paid Secretary or any other person or persons to attend to or supervise or conduct specified jobs or functions or entrust matters in such manner and subject to such rules and regulations as the trustees may prescribe.

- (iv) To authorize any one or more trustees to hold any property or any fund or any investment of the trust subject however to the terms of these presents in such manner and subject to such terms and conditions, rules and regulations as trustee/s may from time-to-time think fit and proper.
- (v) To spend any portion of the corpus or the income of the trust for purchasing any land and/or constructing any buildings for and in the name of the trust for the purpose of carrying out, promoting and/or executing any or all of the objects of the trust.

10. OTHER INCIDENTAL POWERS

- (i) The Trustees may invest the Trust funds either in immovable properties or in such manner as prescribed by these presents and as allowed by law as may be in force from time to time and to convert, alter, vary, dispose of or transfer such investments from time to time for better being able to conduct the affairs of the trust consistent with the objects of the trust.
- (ii) If the income from the trust property in a particular year is not fully utilized the unexpended income subject to the applicable provisions of the income-tax Act 1961 as may be amended from time to time or under any provision of Trust law or regulations governing such charitable institutions shall be carried over to the next year or years and spent in such subsequent year or years for the advancement of any of the object of the trust, the money meanwhile being invested in the manner required or permitted by the above said laws.
- (iii) The trustees shall be at liberty to sell such portion or portions of the movable or immovable properties forming part of the Trust Estate either by public auction or by private contract at such price or prices and in such terms and conditions relating to title or otherwise in all respects as they may in their absolute discretion think fit and to rescind or vary any contract for the sale thereof and to resell the same and to execute all conveyance or other

improve and develop and to ultimately cause to be cultivated all or any of the said lands, hereditaments and premises and to insure houses and buildings against loss or damage by fire and/or other risks or to let, lease or make such arrangements with tenants, agriculturists and others generally to deal with the said lands, hereditaments and premises as they may deem fit in their absolute discretion for the benefit of the Trust.

- (viii) The trustees may appoint, employ or engage secretaries, managers, accountants, lawyers or others for the purposes of management and supervision of the Trust Estate for collection of rents, effects and profits, for keeping the accounts and records and for other purposes of the trust.
- (ix) The trustees may establish its office or function at such place or places and may change such places from time to time as they may think fit.
- (x) The trustees may demise the immovable property or properties for the time being and from time to time belonging to the trust either from year to year or for any fixed term or for any term of years on monthly tenancies at such rent and subject to such covenants and conditions as may be considered proper and also accept surrenders of lease and tenancies and generally manage the same in such manner as may be considered reasonable.
- (xi) The trustees shall have full power to compromise or compound all actions, suits and other proceedings and settle differences and disputes touching the trust Estate and/or the Trust properties and to refer any such differences of disputes to arbitration and to adjust and settle all accounts relating to the Trust Estate and/or

14. AMENDMENT TO THE TRUST

It will not be open to the trustees to amend the objects or the terms stipulated in this indenture. If any amendment is necessary for more effective implementation of the objects, it may be made subject to the concurrence of the Commissioner of Income-tax/Chief Commissioner of Income-tax/Director of Exemption or any other concerned authority under direct tax laws in order that the trust may continue to have the status of a public trust under section 11 of the Income-tax Act or section 2(15), 11, 12, 13 and 80G of the I.T. Act 1961 and any analogous sections under similar others laws, now or as may be amended from time to time.

The Trustees may unanimously decide by Resolution recorded in the Resolution Book maintained by the Trust, to alter, vary, add or to delete any of the provisions herein contained and they shall be effectual as if they are herein embodied.



15. NO BENEFIT TO AUTHOR, TRUSTEES AND OTHERS

Trustees will not be entitled to any remuneration save right to reimbursement of expenses incurred in the discharge of their duties. Neither the author, trustees nor their families, nor any member of their families nor any of their relatives or concerns in which any of these persons are interested will be entitled to any benefit prohibited by Section 13 of the Income Tax Act 1961 or otherwise directly or indirectly from the Trust.

16. INDEMNITY FOR TRUSTEES

Trustees will not be personally liable for any act bona fide done on behalf of the Trust in the course of duties as a Trustee. The Members of the Board of Trustees shall be indemnified against any loss incurred or suffered or any payments made by them in the administration of the Trust and such expenses, losses and payments as ratified by the Board of Trustees shall be borne by the Trust.

17. SUITS & PROCESSES

The Managing Trustee may sue and be sued in the name of the Trust.

18. MEETINGS

The Board Meeting will be held, at least, once in three months, notice of such meeting being given, at least, a week in advance. Decisions will be taken as far as possible by consensus and in the event of any difference by majority. Where the votes are equal, the Chairman will have the casting vote. There will be no quorum for such meetings. Resolution by circulation is permissible.

19. ACCOUNTS

Accounts will be kept for the Trust and closed on every 31st March and such accounts shall also be audited by a qualified Chartered Accountant within six months from end of the accounting year.

20. RECORD

Board will cause a record to be kept of investments and disbursements besides a Minutes Book recording all resolutions and proceedings for every meeting duly confirmed at next meeting and attested by the Chairman of the next meeting.

21. SAVING CLAUSE

If the object or any of the powers or any provision in the Trust Deed is inconsistent with requirements of law relating to Public Trust or Trusts eligible for exemption under the Income-tax Act, or any other direct tax law, such object, power or provisions will stand modified to the extent that they should accord with such law so as to continue to be eligible to be treated as a Public Charitable Trust.

22. RESOLVING DISPUTES

If there be any doubt about interpretation of this Deed or about duties, the matter shall be referred to an arbitrator chosen by a consensus among the trustees and his decision shall be accepted. ...17

In case it becomes necessary to wind up or otherwise determine this Trust for whatever reason, neither the author nor his heirs nor the Trustees for the time being nor any other person shall have any manner or right over such funds of the Trust or any other property. The net funds and other assets, if any, after meeting all liabilities will be handed over to any other similar Trust or Institution similarly satisfying requirements of Income-tax Act, 1961 as may be decided by the last Trustees subject further to the condition that it shall be so given to an Institution as approved by the Commissioner of Income-tax or Director of Exemptions as the case may be.

24. JURISDICTION:

All disputes as to the Trust, Trustees and Funds of the Trust be instituted within the jurisdiction of Civil courts at Udupi only and vno other courts shall have jurisdiction to try the same.

25. AREA OF OPERATION:

The area of operation of the Trust shall be restricted / confined to the territory of India and that all activities will be carried out within the territory of India.

26. INSTRUMENT OF TRUST:

The original Deed shall remain under the custody of the Managing Trustee at the Principal place of the Trust.

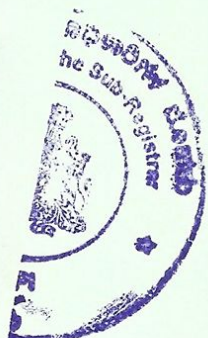
